Eligibility: Entrants must be at least 18 years old to enter/win as of ticket drawing start date. To enter the ticket drawing, members may complete the form provided on the UHCU website. In addition to access through personal web access devices, online access is available in UHCU lobby locations. Entry may be completed orally via phone by contacting any number listed above and speaking with a UHCU representative. Entries may also be mailed to PO Box 202020 Austin, TX 78720, c/o Operations Department and must include the entrant's full name, address, contact phone number and email. Tickets are \$5.00 each for children and adults. Funds must be available in the account number provided at time of registration. Each entry is eligible for up to four (4) tickets per primary account holder. Entries will be reviewed prior to drawing and duplicates will be removed. Members may choose one (1) event date to attend. Event dates are Saturday, July 30, 2022; Sunday, July 31, 2022; and Saturday, September 10, 2022. UHCU membership is required.

Conditions of Participation: Participation in the ticket drawing constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of UHCU, which are final and binding. Participation in the ticket drawing is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein. The ticket drawing is subject to all applicable federal, state and local laws. By participating, entrants agree to be bound by these Official Rules, as interpreted by UHCU in its sole discretion. UHCU is not responsible for lost, late, misdirected, undeliverable or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmission, typographical or system errors and failures, faulty transmissions, technical malfunctions or otherwise. UHCU may prohibit an entrant from participating in the ticket drawing if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the ticket drawing by cheating, deception or other unfair practices or intending to annoy, abuse, threaten or harass any other entrants or UHCU. If for any reason the ticket drawing cannot be conducted as planned, including, but not limited to fraud or any other causes beyond the reasonable control of UHCU which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion, then UHCU may in its sole discretion cancel, terminate, modify or suspend the ticket drawing, and may select from those entries received up to the cancellation/suspension date.

Registration Period: The ticket registration period begins on June 6, 2022 at 9:00 AM Central Standard Time (CST) and ends on June 30, 2022 at 11:59 PM ("Registration Period"). Entries that are submitted before or after the Registration Period will not be accepted. Submissions will be accepted for the duration of the Registration Period.

Ticket Drawing: Ticket recipients will be randomly drawn from all eligible entries received during the Registration Period. The ticket drawing will be conducted by UHCU. Chances of being a ticket recipient based on number of entries received during the Registration Period.

To Claim Ticket(s): Ticket recipients randomly selected to purchase tickets will be notified via email on July 7, 2022. Need not be present to be selected. Tickets are \$5.00 each for children and adults. Funds for total number of tickets requested will be withdrawn from the account and share indicated by the entrant on the form submitted during the Registration Period. When recipient is notified he/she has been randomly selected to purchase tickets, recipient may contact UHCU to refuse ticket purchase. Recipient must contact UHCU by July 14, 2022 to refuse ticket purchase. If this occurs, the entry will be removed and an alternate ticket recipient will be selected/drawn. Tickets will be provided to notified members at the UHCU check-in table at the Dell Diamond on the specific day under the name provided on the entry.
